### **Cross-border cooperation within EUSAIR**

### **EUSAIR** is a **strategic framework** for CBC:

- @ programming: direction for selecting objectives
- @ project selection: direction for selection criteria
- @ implementation: monitoring / evaluation focus

### **COMPLEMENTARITY**:

- EUSAIR/transnational: strategic policy-making mainly at national/ subnational governance levels (NUTS I/II)
- CBC: mainly local level's needs, services –small investments (NUTS III)

#### **Geographic alignment** of our programme:

- Even though at the very heart of the Adriatic Sea
- It only covers a part of the EUSAIR area
  Thematic alignment of our programme:
- Even though priorities are similar
- They are set in the 2014-20 IPA Regulation (& 2021-27 ERDF) with a slightly different scope ... therefore NEVER 1 to 1, NEVER completely overlapping!



# Alignment during project selection

- **Required** for all project applicants
- To specify how they contribute to the EUSAIR objectives
- ✓ To precisely specify which action
- Selection criteria applied by assessors (targeted):
- A.9. The project clearly contributes to the EUSAIR macroregional Strategy (5 points) +
- D.3. The project objective and activities are explicitly foreseen in the EUSAIR action plan, the project clearly outlines how these activities are going to be followed up on EUISAMRE (Se points)

    - b) focused meetings (8 in 2020)
    - c) consultation event (18 Jan 2021)
    - JS/MA facilitate the process (territorial analysis, etc.)
  - Nothing is approved yet (Regulations funds?)

- E.g. capitalisation with ADRION: On-going ADRION capitalisation providing inputs during first calls (end 2021 beg. 2022) (?)
- **Focus on EUSAIR** pillars/actions in 2021-27 calls
- EUSAIR pillar and national coordinators: Improved information flows
