ANNUAL PROGRESS REPORT FOR YEAR 2022

Prepared by Pillar Coordinators, supported by the relevant EUSAIR Facility Point Project Partner, and approved by TSG 4 members on 1.2.2023 through written procedure

Background:

As provided in the TSG Rules of Procedure (Point 8), every year, by end-February, Pillar Coordinators shall submit to the Governing Board an Annual Progress Report for the pillar concerned covering the preceding year (1st January-31st December).

The Annual Progress Report, jointly prepared by Pillar Coordinators, with the support of the relevant EUSAIR Facility Point Project Partner, is approved by the respective TSG prior to transmission to the Governing Board.

The Governing Board will be called to take note of the aforementioned reports, and, on that basis, to establish an Annual Progress Report for the EUSAIR as a whole, to be presented to the EU-28 High Level Group on macro-regional strategies and to the EUSAIR political/ministerial level.

General remarks:

The following table of content and the template itself show the sections that should be completed (none of them should be left blank or deleted from the report). If necessary and justified, additional (sub) sections could be added.

The report shall not exceed a maximum number of <u>5 pages</u> (*Arial 12 or equivalent*).

Additionally, please note the following:

- The information should be well-structured within each of the sections and should be synthetic and to the point, addressing the content and not aiming for quantity.
- Do not include information which could be found elsewhere, e.g. minutes of the meetings or list of TSG members.
- The language should be direct and clear. Using acronyms, jargon or internal technicalities is not recommended.
- Refer to factual information, and be as concrete as possible. Vague and general comments (e.g. "the situation is progressing favourably and quite rapidly") without justification should be avoided.
- Any other important information (monitoring reports etc.) should be added as annexes.

TSG PROCESS (GOVERNANCE)

TSG governance process is defined by the EU Strategy for the Adriatic and Ionian Region (EUSAIR) and its Action Plan as key documents to implement sustainable development in the macro-region. Four Pillars that address the core challenges and opportunities for the macro-region are defined by the Action

Plan. All pillars are co-chaired by EU and non-EU countries. According to this, Republic of Croatia and Republic of Albania are co-chairs of the Pillar 4 – Sustainable Tourism.

Since December 2022 a new co-chair for TSG4 for Albania, Mrs. Herida Duro, has been appointed. At the 17th TSG4 meeting representatives of the new EUSAIR member country- San Marino were welcomed.

Following the setting-up process of TSG4, all countries nominated their representatives in TSG4, and the Rules of Procedures of TSG4 were adopted in 2015. Most countries have also appointed their deputy representatives, and representatives of the national ministries of culture in line with their chosen priorities.

TSG4 organized three meetings in 2022: 17th meeting online (4th May 2022, 18th meeting hybrid (18th October 2022) and 19th meeting online (25th November 2022). At the 17th and 18th meetings, all of the countries were present and at the 19th meeting, eight of the nine countries of the EUSAIR TSG4 were present, while North Macedonia was absent.

17th **TSG4** online meeting was also attended by the European Commission (DG REGIO), Facility Point Lead Partner, FP Croatia Communication and Innovation experts; contracted experts for Strategic Project development and experts for Monitoring and Evaluation, ESP technical support, and representatives of EUSDR, ESPON and CoE.

18th **TSG4** hybrid meeting was also attended by the European Commission (DG REGIO), Facility Point Lead Partner, ADRION, FP Croatia Communication expert; contracted experts for Strategic Project development and Monitoring and Evaluation, representatives of CoE – EICR and AI-NURECC.

19th **TSG4** online meeting was also attended by the European Commission (DG REGIO), Facility Point Lead Partner and contracted expert working on the AP revision process.

1) TSG4 - meetings:

In the TSG4 meetings, the following key issues were discussed, in order to ensure an efficient implementation of EUSAIR and its Action Plan.

- 17th TSG4 meeting: The new TSG4 MS San Marino representative was introduced and warmly welcomed. The report on the 16th TSG4 meeting's conclusions and implementation were approved. A short report on the GB meeting, held in March, was given, as well as the information on the development of ADRION programme, report on the process of embedding and outcomes of the EUSAIR evaluation process. Draft background paper on the EUSAIR Action Plan revision was presented.
- TSG4 members were invited to give proposals for the TSG4 session at the 7th EUSAIR Annual Forum in Tirana from 16th to 18th May 2022.
- TSG4 members were informed about the various activities within the EUSDR and invited to participate in conferences and workshops to strengthen the cooperation within MRS.

 The 11th Annual Advisory Forum on the Cultural Routes of the Council of Europe was announced to be held in Greece from 5 to 7 October 2022 with the special session on Adriatic Ionian Region and MS were invited to take part.

• 18th TSG4 meeting:

The new Albanian coordinator was introduced. The report on the 17th TSG4 meeting's conclusions and implementation were approved. Report was also given on TSG4 Panel prepared within the 7th EUSAIR Forum held in Albania, in May. EC presented several open calls and initiatives, such as New European Bauhaus (NEB) or European Urban Initiative. Developments regarding the Tourism Transition Pathway and conclusions on the European Agenda for Tourism 2030 were presented. ADRION JS presented the new IPA ADRION programme. TSG4 members were informed on European Transnational Cooperation funding opportunities for the period 2021-2027, as well as on AI-NURECC initiatives and activities.

The cooperation with CoE EICR was highlighted. The 11th Annual Advisory Forum on the Cultural Routes of the Council of Europe was successfully held in Greece 05th-7th October 2022, for the first time with the EUSAIR TSG4 special session on 7th October 2022, on cultural tourism products on cultural routes with 9 speakers presenting best practice examples in EUSAIR.

TSG4 members were informed that documentation development is completed for 4 mono-pillar projects': AIR Cultural Routes, CruiseAIR, ProDestAIR MIQS and Living the Sea 4.0 with tentative partner structures and budgets. TSG4 flagship project ideas were presented in some 20 occasions on meetings and workshops. TSG4 members were informed on progress in issue papers development on Wellbeing and Gastro tourism in EUSAIR MS. TSG4 members confirmed the proposed content of the new issue paper/ mini study to be developed on "Attitudes of EUSAIR visitors towards tourism". TSG4 members approved the report on the activities of the TSG4 monitoring and evaluation experts with a conclusion that in all MRS, EUSAIR is the only strategy that has a specific pillar covering sustainable tourism as an important value for the future. TSG4 members were informed on the activities of the communication external experts. MS were also informed on the EUSAIR FP future plans and the revision process and an additional ad hoc meeting with TSG4 was scheduled.

• 19th TSG4 ad hoc meeting:

The 19th ad hoc meeting was thematically fully dedicated to the AP revision process. The external expert explained the revision procedure to TSG4 members. All comments on Initial policy paper and questionnaire given by TSG4 members are taken into consideration by the experts and adopted in the documents. TSG4 members were informed that the questionnaires could be adapted/shortened for relevant stakeholders in order to fill them in well. Country inputs questionnaires were expected to be sent by TSG members to Pillar 4 Coordinators, Pillar thematic experts, EC representative and FP Lead Partner.

 Capacity Building Event on Monitoring and Evaluation on national level was held in Croatia, Plitvice Lakes National Park, 10th -11th November 2022. with EC and WP leaders.

2) TSG4 - round tables /seminars/ thematic events:

- At 7th EUSAIR Forum realized in cooperation with EC and Albania in Tirana, TSG4 Thematic Session was organized on May 17th 2022 under the title "Navigating Tourism through Policies and Trends" with a subtitle "The Role of Tourism and Culture in the Revision of the EUSAIR Action Plan". Practices were presented by 8 speakers from Greece, Montenegro, Slovenia, Croatia and the minister from Albania. It was attended by approximately 200 people.
- EUSAIR thematic round table, organized at the 11th Cultural Routes **Annual Advisory Forum 2022** on October 5th-7th in the island of Crete, Chania, Greece. The Forum organized by the CoE and Greece, raised huge interest among stakeholders with estimated 430 participants (including 60 online¹). For the first time, as part of the Forum, a Special EUSAIR Session was organized by TSG4, on important topic of cultural tourism product on cultural routes, coordinated by Croatia and Greece and CoE, with 9 speakers presenting best practice examples including keynote speeches from Greece in front of some 100 participants. The session/ round table provided knowledge exchange in expertise in the field of sustainable cultural tourism, and cultural tourism product development on the routes bringing together representatives of routes operators, networks, international heritage and tourism organizations, local and regional authorities, and other professional organizations in the field of tourism, heritage and culture. EUSAIR thus stimulates cultural routes, promoting dialogue between urban and rural cultures, between developed and disadvantaged regions through: mobility, diversification, sustainable management and sustainable growth.

MAIN ISSUES/CHALLENGES ENCOUNTRED

- · Match-making process between funds and project ideas;
- Fluctuating MS human resources supporting EUSAIR lack of continuity in appointed representatives (Albania often changes coordinator);
- Need for reinforcement of fluctuating human resources on all levels, administrative capacity and practical experience has to be enhanced;
- Administrative commitment to the strategy needs to be strengthened;
- Need for the awareness raising of high level administration, especially regarding the value and operational achievements of EUSAIR.

THE WORK AHEAD

In the year, 2023 TSG4 will mainly focus on:

• Implementation of recommendations and conclusions of TSG4, Governing Board and EUSAIR Forum;

- Organisation of twoTSG4 meetings (20th in Bosnia and Herzegovina, on March 28th/29th), one accompanied by thematic round table;
- Kick off meeting for Presidency including panel on activities completed in former period;
- Thematic ad hoc events organisation of thematic and/or project oriented events/workshops;
- Further implementation of activities for development of Sustainable tourism in the Adriatic-Ionian region as continuation of the activities (one issue paper/ mini study);
- Further discussing actions/priorities that have macro-regional value in sustainable tourism at the next TSG4 meeting and presentation of the Issue Papers within the meeting;
- Contribution to the 8th EUSAIR Forum organized by B&H in accordance to the Agenda of the Forum;
- Financial dialogue;
- Further cooperation with international initiatives: CoE; UNWTO; etc.;
- Maintaining and improving cooperation among TSG4 members and between pillars to achieve the best output for all of them;
- EUSAIR Capacity Building Event on Monitoring and Evaluation on national level - in Greece, Athens 28th February 2023.
